Formal notice of deferred national conference 2020

The deferred Fórsa National Conference 2020 will take place on a remote basis on Thursday 19th November. Registration of Principal Delegates will commence at 09.00am. The conference will commence at 10.30am, and conclude by 5.30pm.

As I set out in my letter of 31st July, the NEC has decided that, due to the prevailing public health restrictions, this will be a 'remote' conference. The NEC has also decided that the associated officer elections will be conducted by secure postal ballot.

Principal Delegates

In light of the NEC decision to conduct the officer elections by secure postal ballot, Branches must register their Principal Delegates with the union, by email, by 1st September at the latest. Registration is open now and, if you have not already done so, using the attached form, you should forward the name of your Principal Delegate to eelliott@forsa.ie as soon as possible and by 1st September at the latest.

Only Principal Delegates will be authorised to participate in the remote conference on Thursday 19th November (the proceedings will be available for all activists and members to view via live-stream).

Officer elections

The candidates for election to officer positions are listed in the 'provisional final agenda' for conference, which I emailed to branches on 28th April 2020.

Ballot papers will be sent by recorded delivery to Principal Delegates at the address they have supplied. Ballot papers will not be given or sent to any other person.

Principal Delegates will be supplied with return envelopes, which should be used when completed ballot papers are returned. Completed ballot papers should be returned by recorded delivery.

Motions and amendments

SOC Report No.2 made recommendations on how conference business should be handled. This report was contained in the 'provisional final agenda' for conference, which I emailed to branches on 28th April 2020.

Emergency motions relating to events in the period between the original deadline for conference motions and 31st August 2020 must be received, in writing, in the General Secretary's office not later than the deadlines set out below. Please use the form attached to this email and mark envelopes: "General Secretary: Conference 2020."
